The Challenge

For Italian football giant A.S. Roma, being a championshipcaliber organization in Serie A and the UEFA Europa League means more than putting together a competitive team on the pitch. To keep its operations running smoothly and engage with its worldwide fanbase, the team employs more than 200 people in Rome, London and Boston. With that large of a team, and across those geographies, maintaining collaboration, security, and compliance is no small task.

"As a digital media department we have several people working with us in different time zones," said A.S. Roma social media manager Emanuele Russo. "Our group includes video editors, journalists and photographers."

For CTO Fabrizio Petri, having used Box and Dropbox, it became apparent quickly that there was a need for an enterprisegrade file-sharing and data governance platform with a hybrid architecture that could maintain the control and visibility of 87M+ Fans

content flowing through the club. The lack of visibility exposed A.S. Roma to unwanted regulatory attention and the critical nature of the content (like player fitness or a contractual status) could have led to fines and sanctions in multiple jurisdictions.

"We tried a lot of platforms before, but we came into a situation where everyone was using their own platform and it generated a lot of confusion," said Russo.

The Solution

Having evaluated numerous solutions offered by Box and Dropbox, A.S. Roma concluded these 'consumer-file sharing' applications lacked the centralized control and user permissions the club couldn't live without.

But Egnyte did.

"When we decided to implement a document sharing system," Preti said, "we analyzed the different solutions on the market. Egnyte started from an enterprise point of view. The other solutions on the market started from the consumer point of view."

A.S. Roma embarked on a paid pilot to test functionality, reliability and user acceptance. Photographers and members of the social media team were given access to Egnyte, and match photos were uploaded to shared folders to be published during games.

The granularity of the permissions provided high levels of security and access control. Real-time reporting features ensured complete visibility of all image-sharing activity. The speed of upload, even on crowded stadium WiFi, was impressive and feedback from users was positive from the outset.


