Overview




Figure 1 – Value driver contribution to total ROI

Egnyte minimizes data exposure and ransomware threats through advanced prevention, recovery, and integrated security controls, often leading to lower cyber insurance premiums.




Figure 4 – Average annual savings and value for each major risk cost category, along with the total yearly & three-year averages (after Egnyte investment) across all assessments

Example Areas of Value

Example Areas of Value

Example Areas of Value

Typical Buyer Challenges

- On-premises Windows file server that lacked critical features around security and governance
- Legacy system didn't have any sort of content controls to prevent inappropriate disclosure
- Teams in various locations using various systems to manage a large and diverse volume of content – created significant headaches.
